

# Q1 Has your home group held (or scheduled) a group conscience or business meeting to consider resuming face-to-face meetings?







# Shared Experience from our Panel (by question number):

- 17. Have dues been addressed in terms of smaller groups due to social distancing being able to pay rents?
- ——We have had a few discussions with our group and the church. We will not be going back before phase 3 anyway. The church encouraged this too. Also we will not be using their kitchen and utensils until given the ok by the church.
- 21. How does a group keep the same 15 people once word gets out live meetings it may be hard to keep same 15
- —I think this one is perhaps the most challenging for the groups to figure out and it goes along with the contact tracking and the anonymity ramifications. I think the groups need to discuss this requirement with both the landlords and with group members to determine what their plan will be. Having the "same" 15 people is more of a guideline than an executive order, so I can't see that being enforced. I know it's not being enforced in other public venues. Contact tracking is a whole other matter. I don't see that being enforced in any public venues either, but the hall or church may require it. Perhaps Area should model something once you start meeting together again? Names and phone numbers?
- 26. Will research this myself as well. Church is a non-profit, religious org. It rents space, becoming a non-profit, religious landlord. They exist to help those in need. They see the need for meetings from their eyes. They sacrifice much to do this. Many of them will never turn away a sick or suffering alcoholic. Why should they? Booze sellers were open and some may have needed it to ward off the DT's. Or do we just let people die? I had hoped this would have been discussed. Thank you.
- ——I'm guessing you're asking why a 12 step meeting doesn't follow the guidance for church's. If that's the question, the answer is simply that's not how the Dept of Health classifies our meeting. It's not a judgement. But as I mentioned on the zoom, if the goal is to get a larger number of people together under the church limits, you can, you just need to be in the sanctuary. The intent is that those spaces are huge and that it's easier to space out. Just because my home group meets in a church doesn't enable us to use the same limit. Our room is tiny. Talk to the minister and see if you can use the sanctuary. Plus be sure to see the new phase three limits they're soon to be 50-75 indoors starting in a few weeks. That will render this issue moot for most groups.
- 27. I didn't understand the contact tracing definition and how that applies to AA?
- ——Ideally a group would take a name and phone number of those attending. I think this can work and still respect folks' anonymity. The secretary would just need a first name and a number. The idea is if someone tests positive the department of health will want to inform the other members that they may have been exposed. And it's all voluntary if someone refuses to give their name and numbers, say thanks and move on.
- --The most important thing to realize is that this is a recommendation, not a requirement. A group can choose not to do this.
- 28.1. Prudent reserve considerations? We have been increasing reserves due to concerns about pésenles related to purchasing supplies, deposits if a new venue is required, etc. Has the Area discussed this?
- —Again, groups are autonomous and will have to decide if they should increase their prudent reserve. But if they made it through this far, than they probably will be OK. I know in my group our prudent reserve was tested and we had sufficient funds to continue to pay the church rent for the past three months. That to me means we set it at a reasonable amount and it did it's job, and now hopefully we will begin to see more contributions coming back into the coffers.
